

## STATEMENT

of executing the briefing for students of STU MTF, TU and UCM in Trnava accommodated in Hostel and Canteen of M. Uher in Regulations of Occupational Safety and Health Protection and Fire Protection

### **I. Occupational Safety and Health Protection**

1. Act No 24/2006 Coll. on Occupational Safety and Health Protection and on the amendment of Certain Acts as amended by Act No 309/2007 Coll., Act No 140/2008 Coll., Act No 132/2010 Coll., Act No 136/2010 Coll. and Act No 470/2011 Coll.
2. Concept of Occupational safety and health at STU MTF workplaces.
3. Methodical Regulation of the Ministry of Education, Science, Research and Sport of the Slovak Republic No 4/2009-R, to implement unified procedure of schools, educational institutions and universities in occurrence of registered accident/injury and administration of dangerous events.
4. Briefing of employees (students) without electro-technical qualifications according to Sec. (§) 20, Regulation of the Ministry of Labour, Social Affairs and Family of the Slovak Republic No 508/2009 Coll., by which the details on ensuring the occupational safety and health protection for the operation of technical pressure, lifting, electric and gas devices – are stated.

### **II. Fire Protection**

1. Act of National Council of the Slovak Republic No 314/2001 Coll. on Fire Protection as amended.
2. On STU MTF fire documentation (Dean's Regulation No 6/2019, fire alarm, regulations, evacuation plan, etc.).
3. Regulation of the Ministry of Interior of the Slovak Republic No 719/2002 Coll., by which the properties and conditions of a fire prevention patrol's operation is determined.
4. Regulation No 121/2002 Coll. on fire prevention as amended.

I declare that I acquainted with the aforementioned acts, regulations and the principles of safe behaviour and accommodation in the student hostel. I was noticed of:

- sources and possible reasons of accidents/injuries,
- origin of fire, obligations in case of fire alarm occurrence,
- restriction to use electric heating appliances,
- restriction to smoke in the Student Hostel,

and I was briefed in Occupational Safety and Health Protection and in Fire Protection

#### **I commit myself that**

- I shall follow the regulations of Occupational Safety and Health Protection and in Fire Protection,
- I shall act in a way so that I do not expose my life and health nor the life of health of others to danger,
- I shall always follow the basic rules of safe behaviour and thus avoid accidents/injuries,
- in case of finding a drawback threatening safety or health, I shall immediately notice Hostel receptionist in service,
- I shall not smoke and manipulate with open fire in the Hostel,
- I shall not leave the turned on electric appliances in the kitchens unattended and I shall follow the restriction of using not allowed appliances in the Hostel,
- I shall use only electric appliances allowed by Slovak Technical Standards,
- I shall follow the Hostel Rules of the Hostel and Canteen of M. Uher,
- I shall acquaint myself with the documentation of fire prevention placed on notice boards and follow their directions,
- I shall not damage the extinguishing means – manual extinguishers, fire water supplies, etc.,
- In case of noticing fire, I shall try to extinguish it if possible, or I shall immediately raise an alarm by calling "HORÍ" and call for help according to fire regulations and evacuation plans,
- I shall respect all measures or directions related to Occupational Safety and Health Protection and Fire Protection,
- in case of accident/injury occurrence, I shall immediately notice the Head of the Hostel and Canteen of M. Uher. If I witness the accident/injury, I am obliged to provide immediate first aid.
